Terms & Conditions

1. Health Guarantee

LBK guarantees the puppy is in good health at the time of sale, current on vaccinations, and free from Distemper, Parvo, Parainfluenza, and any life-threatening genetic defect. However, minor cosmetic imperfections such as scratches, nicks, or scrapes may occur due to normal puppy play, especially in older puppies.

2. Shipping & Transportation

The Buyer is responsible for all shipping costs and coordination. LBK may provide recommendations for transport but assumes no responsibility for delays, fees, losses and/damages or other shipping-related matters. LBK has no control over these conditions once the puppy is handed to the transporter. These risks and dangers may be caused by the negligence of the transporter, general travel conditions, or exposure to diseases in transit. The buyer is responsible for choosing a transporter and ensuring they meet safety and health standards.

3. Vaccinations & Deworming

The puppy will receive its first round of vaccinations and one deworming prior to sale. The Buyer must follow up with additional vaccinations and deworming as recommended by their veterinarian. Failure to continue proper vaccinations and deworming will void any health guarantees.

4. Veterinary Examination

The Buyer must take the puppy to a licensed veterinarian within two (2) weeks of receiving the puppy. If a life-threatening genetic defect is found during this time, LBK will provide a replacement puppy of equal value if available from the litter or a credit to another litter at LBK. The Buyer is responsible for all return and replacement shipping costs. LBK reserves the right to request a second veterinary opinion.

5. Safe & Legal Ownership

The Buyer agrees to provide a safe home for the puppy and shall not use it for any illegal activity. LBK does not tolerate dog fighting or neglect and abuse of dogs and reserves the right to reclaim the puppy if it is found to be used in such activities, situations or conditions. Legal action may be pursued to regain rights to the puppy at the buyer's expense.

6. Deposit & Payment Policy

A deposit is required to hold a puppy that is selected by the buyer. The full payment must be made by the time the puppy reaches 4 weeks of age. Failure to complete payment will result in forfeiture of the deposit. Deposits and payments are non-refundable but may be transferred to another available puppy or future litter if LBK is notified before the puppy reaches 4 weeks of age.

7. Boarding Fees

Puppies remaining with LBK past 12 weeks of age will incur a boarding fee of \$350 per week unless prior arrangements are made.

8. Coat & Skin Conditions

Buyers of blue-coated puppies should be aware that they are more prone to skin and coat conditions. LBK does not guarantee against skin or coat issues common to dogs with blue coloring.

9. Return Policy & Shelter Prohibition

If the Buyer can no longer care for the dog, they must notify LBK. The Buyer may not surrender the dog to an animal shelter or rescue. LBK reserves the right to approve any new home and require a signed contract with the new owners. LBK will accept the dog back but does not provide refunds.

10. Hip & Elbow Dysplasia Disclaimer

Due to the size of XL Bullies, LBK does not guarantee against Hip or Elbow Dysplasia. Environmental factors such as diet and activity level influence joint health, and while LBK strives for sound structure, the Buyer assumes all risk. Pet insurance is highly recommended.

11. Registration & Paperwork

LBK reserves the right to include its kennel name on the puppy's registration paperwork. The puppy's registered name may not be altered illegally. If paperwork is lost, a fee will be charged for reissuance.

12. Breeding Rights & Limited Registration

- Full Registration: LBK retains the right to use any male sold with full registration for one breeding. This breeding is for LBK's program only, not for outside breedings.
- Limited Registration: Puppies sold with limited registration must be spayed/neutered by one (1) year of age. Proof of spay/neuter must be provided to LBK before registration papers will be released. Unauthorized breeding of a limited-registration puppy is a contract violation, and the Buyer agrees to pay \$5,000 per puppy in damages plus legal fees.

13. Payment Methods

LBK accepts bank-to-bank wire transfers, cash, PayPal, Venmo, Cash App, or direct bank deposits.

14. Breeding Deposits

Deposits for breedings are non-refundable. If a breeding does not produce the desired pick or sex, the deposit will transfer to a future breeding.

15. Parvovirus Precautions

LBK highly recommends that the Buyer does not place the puppy on the ground in public places until after 18 weeks of age due to the risk of exposure to Parvovirus and other infectious diseases. Dog parks and daycare facilities should be avoided.

16. Necropsy Requirement for Sudden Death

If a puppy dies suddenly, the Buyer must have a necropsy performed by a licensed veterinarian to determine if the cause of death was a congenital defect. The Buyer must submit a written diagnosis, necropsy report, and registration papers to LBK before a replacement puppy will be considered. Shipping costs for the replacement puppy are the Buyer's responsibility.

17. Temperament Disclaimer

LBK does not guarantee specific personality traits. The Buyer is responsible for training and socialization. LBK will not replace a puppy due to personality concerns.

18. Bite Alignment

LBK does not guarantee bite alignment at maturity. The American Bully is a hybrid breed influenced by bulldog genetics, making bite shifts possible.

19. Right to Refuse Sale

LBK reserves the right to terminate a sale at any time prior to the transfer of possession.
